



**VILLAGE OF LOUGHEED
BYLAW 767-17**

**BEING A BYLAW OF THE VILLAGE OF LOUGHEED, IN THE PROVINCE OF ALBERTA,
FOR THE PURPOSE TO REPEAL ALL OUTDATED, OBOSLETE OR CONFLICTING
BYLAWS.**

WHEREAS Section 191 of the Municipal Government Act provides that a council has the power to pass a bylaw and includes the power to amend or repeal bylaws.

AND WHEREAS, the Council of the Village of Lougheed wishes to repeal bylaws to provide governance in a straight forward manner without conflicting bylaws and outdated standards and processes.

AND WHEREAS, the bylaw is adopted in accordance with Section 191 of the Municipal Government Act.

THEREFORE under the authority and subject to the provisions of the Municipal Government Act, Revised Statutes of Alberta 2000, Chapter M-26, as amended, the Council of the Village of Lougheed duly assembled does hereby enact the following:


- 2) Bylaw No. 767-17 shall come into effect upon third and final reading thereof
