



VILLAGE OF LOUGHEED

BYLAW 754-15

BEING A BYLAW OF THE VILLAGE OF LOUGHEED, IN THE PROVINCE OF ALBERTA, FOR THE PURPOSE OF AMENDING THE VILLAGE OF LOUGHEED LAND USE BYLAW NO. 705.

WHEREAS the Council of the Village of Lougheed considers it necessary to amend the Land Use Bylaw No. 705, and

WHEREAS, the Council has the authority pursuant to the provisions of the Municipal Government Act, Revised Statutes of Alberta, 2000, Chapter M26, to amend the said Land Use Bylaw No. 705,

WHEREAS, property owners may apply to the municipality for a bylaw authorizing Land Titles to cancel registration of two or more lots and consolidate, creating one (1) lot, with one (1) Linc Number,

NOW THEREFORE, the Council of the Village of Lougheed, duly assembled, enacts as follows:

THAT the Land Use Bylaw No. 705 be hereby amended as follows:

Cancellation of Village of Lougheed Lots as listed below and Registered at Land Titles, and Finally Consolidate two or more adjacent lots into One (1) Residential Lot with One (1) Linc Number.
