THAT Council support for 988 Crisis Line

- WHEREAS the Federal government has passed a motion to adopt 988, a National three-digit suicide and crisis hotline;
- AND WHEREAS the ongoing COVID-19 pandemic has increased the demand for suicide prevention services by 200 per cent;
- AND WHEREAS existing suicide prevention hotlines require the user to remember a 10-digit number and go through directories or be placed on hold;
- AND WHEREAS in 2022 the United States will have in place a national 988 crisis hotline;
- AND WHEREAS Lougheed Council recognizes that it is a significant and important initiative to ensure critical barriers are removed to those in a crisis and seeking help
